

verification of Character & Antecedents.

- b) The fact that the name of the candidate figures in this list does not give him any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- c) This select list is subject to the final decision of the Hon'ble Karnataka Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
