PROVISIONAL SELECT LIST


1. In pursuance to the Notification dated: 17.10.2015 cited at reference-1, recruitment process to fill up 51 posts of Armed Reserve Sub-Inspector (CAR/DAR) including in-service was initiated and after completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009, Provisional Select List cited at reference-2 was published on 29.06.2016.

2. Whereas, after publishing Provisional Select List for the above post, selected candidates were subjected to Medical Examination before duly constituted Medical Board. One candidate who was selected for the post viz., Sri Parashuram bearing Roll No. 9110957 was declared unfit by the Medical Board vide report cited at reference-3. Accordingly, the candidature of Sri. Parashuram, was cancelled vide order No. 18/RECT-2/2015-16, Dated: 19.8.2016 cited at reference-4.

3. Whereas, due to cancellation of the candidature of Sri.Parashuram, one post in Armed Reserve Sub-Inspector(CAR/DAR) has remained unfilled. In order to fill up the post this Provisional Select List is being published with the following conditions:

- This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- The fact that the name of the candidate figures in this list does not give them any legal right for appointment to the post which will be dependent on the aforesaid condition.
- This select list is subject to the final decision of the Hon'ble Karnataka Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
